1	Elmslie	N/A	Corporate Services	Can all of the work be managed within the timeframe?	The capital budget process has regard for staff resources and carryover capital work. Staff is confident that substantial completion of proposed 2023 capital projects is achievable within two years of approval.
2	Perry	N/A	Corporate Services	Is there any way in the budget to somehow assist residents with the impacts of inflation?	The proposed budget accounts for achievable works based on resources available, and meets funding targets in our Long Term Financial Plan. Staff are recommending contributions to reserves from any surpluses to manage forecasted 2023 inflationary impacts.
3	Perry	N/A	Corporate Services	Would we consider a tax increase this budget for roads this year e.g. a specific roads levy? Roads came up at 95% of the doors during the campaign this fall. Would more money help? If so, how would we best show residents that the roads increase is going straight to roads?;	In 2022 Council adopted a dedicated capital levy which is used to support the Asset Management Reserve and roads. This levy was considered to be "affordable and sustainable" for taxpayers, while getting further ahead on our asset/infrastructure deficit. A future update to council on the City's 5-Year roads plan will come forward later.
4	Warren	N/A	Engineering	Is there a formula for using the Federal Gas Tax.? Can it be used for other capital except roads?	The City has traditionally allocated 100% of its Federal Gas Tax Fund Grant (now Canada Community Building Fund Grant) allocation to roads. Diverting such financing to another purpose would only create the need to backfill the financing with taxes or another a tax-supported source.

16	Warren	206	Engineering	Would council consider a decision unit for lights at 36 and Boyd/Canal Streets, engineered 2023 and 2024 installation?	<p>In the DC study, installation of this new traffic signal is planned for 2027. However, with Canal St. reconstruction now set for later than originally planned (2026 instead of 2021) due to delays with land acquisition, staff aims to undertake the two projects concurrently. That would entail traffic signal design in 2024, with installation occurring in 2026, accelerating the project by a year. Given Canal St. is scheduled to be reconstructed in 2026, there is no need for further acceleration. But should Council nonetheless direct staff to accelerate the traffic signal design to 2023, staff recommends that it be budgeted \$40,000 and financed 90% by the DC Reserve and 10% by the Asset Management Reserve as per the DC study.</p>
17	Warren	211	Public Works	How much money in Provincial Gas Tax reserve for transit in Lindsay?	<p>Lindsay Transit is close to a 50/50 funding model annual. 50% of the service is funded by the tax base and 50% of the funding is provided by gas tax proceeds. In 2023, Staff proposes to allocate \$700,000 in Gas Tax funding to Transit.</p>

18	Ashmore	223	Community Services	Coronation Hall was to have roof repaired in 2019 and invest in building envelope, why is it not included in budget	The Facility Condition Assessment for this building does not indicate any roof requirement projects and there is no failing currently. No previous indication has advised of any roof requirement and there was no project planned for 2019. The flat roof portion has been previously replaced. There is a Capital Budget item from the 2022 Capital Budget for Foundation repairs and it will be complete in Q2 2023.
19	Perry	223	Community Services	How/where would we insert a request for funding for some additional portable washrooms in Fenelon?	This service has been reviewed with Economic Development and the local Downtown groups they communicate with. Portable washroom locations have been placed accordingly and other options at permanent facilities (Library location) has been added. If another location is desired Council can request for staff to review.

An example is refurbishing the stone walls at the Oakwood Cenotaph. Another example is the tennis courts in Little Britain.</p>	<p>The Oakwood Cenotaph project was done last year by an external group. City staff met with the previous Ward Councillor to discuss the project. Also, staff have met with various community representatives regarding the LB tennis courts. They have not been utilized as tennis courts for a number of years. The community groups are contemplating what they would like to see the location used for. Once they have done so staff will review for feasibility and determine a budget source and request. Also, the 50/50 Capital Project Fund would be a funding source already within City budgets to assist with these projects.</p>
