Unless otherwise specified, prices shown do NOT include applicable HST.

The following format and content of the price list has been stipulated by the Bereavement Authority of Ontario and is required to be posted by all bereavement licensees.

INTERMENT AND SCATTERING RIGHTS

Interment right prices listed below include a non-refundable contribution to the cemetery's Care and Maintenance Fund.* The prices listed below do not include the opening and closing of the grave, niche or crypt ("interment fee"), memorialization costs (flat marker, upright monument, etc.) and associated installation fees.

In-ground burials (includes 40% Care and Maintenance)

Adult/Child/Veteran Grave (32 – 40 sq. feet)	\$1222.00
Cremation Grave	\$774.00

Niches (includes 15% Care and Maintenance)

Columbarium Niche (12" x 12" x 12")	\$1938.00
Columbarium Niche (14" x 14" x 14")	\$1970.00

Scattering Rights (includes Care and Maintenance minimums)

Scattering right (single right holder)	\$285.00
Scattering ground (no right holders)	\$58.00

***Care and Maintenance Fund Contribution:**

As required under the *Funeral, Burial and Cremation Services Act, 2002* and Ontario Regulation 30/11, the amounts below will be contributed to an irrevocable trust fund known as the Care and Maintenance Fund/Account. Income (interest) from this fund is used to cover care and maintenance expenses of the cemetery in perpetuity.

For one in-ground grave, 2.23m ² /24ft ² or larger	40% (or minimum \$290) of the purchase price
For one cremation grave, smaller than 2.23m ² /24ft ²	40% (or minimum \$175) of the purchase price
For one columbarium niche	15% (or minimum \$165) of the purchase price
For one scattering right (single right holder)	40% (or minimum \$115) of the purchase price
For one scattering right (multiple right holders)	15% (or minimum \$30) of the purchase price
Per scattering in a scattering ground (no right holders)	\$30

Surcharge for regular interments on Saturday** before 12:00 pm	\$400.00
Surcharge for winter Interment* of an adult/child at standard depth	\$632.00
Surcharge for winter Interment* of an infant at standard depth	\$250.00

*Winter Interment fee is charged between December 1 and March 31 and is subject to suitable weather conditions. The cemetery operator reserves the sole right to determine if weather and soil conditions are suitable for interment during winter months.

Monument Care and Maintenance Fund Contribution:

As required under the *Funeral, Burial and Cremation Services Act, 2002*, the following amounts must be paid to the cemetery operator before a marker is installed. After each marker installation, the amount will be contributed to an irrevocable trust fund known as the Care and Maintenance Fund. Interest from the fund will be used to cover expenses for the care and maintenance of markers and monuments in perpetuity.

For flat markers measuring less than 1116.13cm ² / 173in ²	\$0
For flat markers measuring 1116.13cm ² / 173in ² or larger.....	\$100
For upright monuments 1.22m / 4ft or less in height and 1.22m / 4ft or less in length, including base	\$200
For upright monuments more than 1.22m / 4ft in height and 1.22m / 4ft, including base.....	\$400

PAYMENT AND FINANCING

Cemetery Service fees are due prior to any interment taking place. Payment may be made by cheque, bank draft, Visa or MasterCard.

Payment plans are available to purchase interment rights. Payment must be made in full before the Interment Rights Certificate is issued and the Rights can be exercised.

Financial assistance for burial and cremation services is available through various governmental agencies, to those who qualify.
