## Application for Affordable Housing

Affordable housing as defined by the City of Kawartha Lakes (City) are housing units with a rent set below the average market rent for the area and also not connected to the community housing waiting list where units are made available at rent-geared-to-income.

Housing providers that are associated with this application process have the same rights to interview applicants, conduct credit checks, ask for landlord reference checks, etc. and ultimately select the households to move into their affordable housing rental units.

The City of Kawartha Lakes is only responsible to manage the affordable housing waiting list. The City is not the landlord.

- Answer all questions in the General Questions section.
- Read and sign the declaration, release and consent.
- Select the number of bedrooms you need and where you want to live.

- Check here to declare that your household is within the household income limits. The minimum annual household income amount is \$44,500 and the maximum annual household income amount is \$66,500.
- Copy of Canada Revenue Agency (CRA) notice of assessment (NOA) for the year previous for all members of the household 18 years of age or older uploaded/included with application. If applying on or after May 1st, the NOA from the previous year is required. For example, a household applies in June 2026 to the affordable housing waiting list, NOA's for the year 2025 would be required.
- Copy of Birth certificate from Canada, permanent resident status in Canada documentation or evidence that your refugee claim has been approved, uploaded/included with application.

Information provided by the household may be shared for the purposes of making decisions or verifying eligibility for assistance under the 'Housing Services Act 2011', the 'Ontario Disability Support Program Act (1997)', the 'Ontario Works Act (1997)' or the 'Child Care and Early Years Act, 2014'.
